5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2082/08/16 at the office Apihimal Rural Municipality Khandeshwori Darchula. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs 51,000.00, for Water Refill Point and Toilet Construction, Rs 44,000.00 for Api Base camp T-House construction, which shall be valid for 30 days beyond the validity period of the bid.
