Apihimal Rural Municipality, Office of the Municipal Executive, Khandeshwori, Darchula, Sudurpashchim Province, Nepal intends to apply part of the funds to cover eligible payments for the Contracts as given in the following table. Bidding is open to all eligible bidders as per Section V of bidding document.
2. Apihimal Rural Municipality, Office of the Municipal Executive, Khandeshwori, Darchula, Sudurpashchim Province, Nepal invites electronic bids from eligible bidders for the Contract given in the following table under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
